

**WESTBROOK CHRISTIAN SCHOOL  
HOLD HARMLESS, RELEASE AND WAIVER OF LIABILITY  
AGREEMENT RELATED TO COVID-19**

The student named below has requested permission to attend Westbrook Christian School (WCS). (“Academic Activity”).

In consideration for being permitted to participate in the Academic Activity, I hereby acknowledge, affirm and agree to the following:

1. I acknowledge that the participation of my child(ren) in the Academic Activity at WCS is voluntary and my child(ren)’s attendance at WCS is not mandatory but of my own choosing. .
2. I am familiar with the Alabama Department of Public Health (“ADPH”) guidelines regarding the Novel Coronavirus Disease (“COVID-19”). I acknowledge and understand that the circumstances and symptoms regarding COVID-19 are changing from day to day and that, accordingly, the ADPH guidelines are regularly modified and updated, and I agree to accept full responsibility for familiarizing myself with the most recent ADPH modifications and updates.
3. I agree that if my child named below begins to experience symptoms similar to COVID-19, I will immediately cease participating in all Academic Activity and notify WCS. I agree to comply with WCS direction and guidelines regarding when my child can return to Academic Activity at WCS.
4. I acknowledge that I am aware that by participating in the Academic Activity that there is a risk of being exposed to COVID-19, and/or any mutation or variation thereof. I am also aware that such an exposure can occur either directly or indirectly whether or not a mask and/or gloves or other protective equipment are worn and that WCS cannot guarantee that by participating in the Academic Activity that there will be no exposure to COVID-19. I further acknowledge that while certain individuals are more susceptible to becoming seriously ill if they contract COVID-19 (such as people over 65, people with serious underlying health conditions, and those with compromised immune systems), anyone, including a healthy person, is susceptible to contracting COVID-19. I have independently evaluated and reviewed the risks of my child and family being exposed to or infected by COVID-19 and have determined to allow my child to participate in the Academic Activity with full knowledge and acceptance of the risks.
5. I understand and acknowledge that WCS cannot eliminate the risk of exposure to COVID-19 and by signing this **HOLD HARMLESS, RELEASE AND WAIVER OF LIABILITY AGREEMENT**, I fully and knowingly agree to ASSUME ALL RISKS associated with my child(ren) participating in the Academic Activity and the exposure to or the infection of COVID-19, including any risk of illness, bodily injury, permanent disability and/or death related, directly or indirectly, to COVID-19.
6. I, on my behalf and on behalf of my child(ren) participating in the Academic Activity, hereby voluntarily and knowingly agree to RELEASE, WAIVE, DISCHARGE and COVENANT NOT TO SUE WCS, including its officers, directors, employees, agents, and/or volunteers, (hereinafter “Releasees”) for any and all losses or damages resulting from illness, bodily injury, temporary or permanent disability, and/or death, whether caused by negligence of Releasees or

which might occur as a result of my participation in the Academic Activity that are related, directly or indirectly, from exposure to or infection with COVID-19.

7. To the maximum extent allowed by law, I hereby agree to INDEMNIFY AND HOLD HARMLESS the Releasees from and against any and all claims, demands, suits, judgments, losses or expenses of any nature whatsoever (including, without limitation, attorneys' fees, costs and disbursements, whether of in-house or outside counsel and whether or not an action is brought, on appeal or otherwise), arising from or out of, or relating to, directly or indirectly, my exposure to or the infection of COVID-19, or arising from or out of, or relating to, directly or indirectly, me exposing or infecting others with COVID-19.
8. I agree that this **HOLD HARMLESS, RELEASE AND WAIVER OF LIABILITY AGREEMENT** shall be construed, interpreted and controlled according to the laws of the State of Alabama.

**IN SIGNING THIS HOLD HARMLESS, RELEASE AND WAIVER OF LIABILITY AGREEMENT, I ACKNOWLEDGE AND REPRESENT THAT I have read the AGREEMENT, understand it and sign it voluntarily as my own free act and deed; no oral representations, statements, or inducements, apart from the foregoing written Agreement, have been made.**
