Dear Parents,

Thank you for enrolling your child in Science Camp 2010. I know we will have a week of learning and fun. I am excited about directing the camp and I expect your child to have a terrific experience.

#### LAB SAFETY

I am very conscientious about lab safety for your child and the others in the classroom. It is absolutely necessary that all children follow the lab rules for this reason. Below is a list of general lab rules that we will follow. All of them are given to help insure we have fun in a safe environment.

1. **NO PLAYING** ---- This is probably the most important rule that must be enforced with children. I want them to have fun with the science, but I cannot allow them to do things that jeopardize safety.
2. **NEVER TASTE OR DRINK ANY CHEMICAL THAT WE USE FOR EXPERIMENTS.** Don't "pretend" to eat or drink chemicals—remember "no playing".
3. No food or drink allowed in the lab. There will be an exception to this in one of the labs.
4. Do not carry out an unauthorized experiment. All directions **MUST** be followed to ensure safety.
5. Stay at your assigned lab station to complete your experiments. I will give you permission to move to another area at times when it is necessary.
6. Tie back long or loose hair. Loose sleeves should not be worn.
7. Westbrook dress code applies.
8. If I have a consistent problem with any young scientist not following lab safety rules, they will have to watch as the experiments are done. If the problem persists, they will not be allowed to continue the camp. Sometimes, children have not reached the maturity level required to be in the lab for an extended time.

Note: Other safety rules and guidelines will be taught on the first day.
